Coronavirus Job Retention Scheme	<p>HMRC will reimburse 80% of your staff's pay (up to a cap of £2,500 per month) if their services are not required during the coronavirus crisis</p> <p>SUBJECT TO CORRECT ADHERENCE TO THE SCHEME PROTOCOLS (see 'How can you access the scheme?')</p>	UK-wide	All subpostmasters with employees	<p>You must designate relevant staff as 'furloughed workers' in order to access the scheme.</p> <p>You should call the NFSP on 01273 452324 (option 1) or professional advice and support from our business partner HR:4UK.</p> <p>HR:4UK will provide resources such as templated letters and agreements for you to use for furloughed workers.</p>
Sick pay support	You can reclaim Statutory Sick Pay (SSP) paid for staff sickness absence due to the coronavirus, covering up to two weeks' SSP per eligible employee. This is available from day 1 of the sickness period.	UK-wide	Subpostmasters with fewer than 250 employees as of 28 February 2020.	<p>Employees need to apply for an isolation note, which is available on NHS website HERE</p> <p>NFSP members can call us on 01273 452324 (option 1) for professional advice from NFSP business partner HR:4UK on reclaiming SSP.</p>

Coronavirus Business Interruption Loan Scheme	<p>Access to loans, overdrafts, invoice finance and asset finance of up to £5 million and for up to six years.</p> <p>Government will cover the first 12 months of interest payments.</p>	UK-wide	This is at the discretion of the British Business Bank's 40+ accredited lenders - through which the scheme is available.	<p>Currently open for applications. Deferral of VAT	VAT payments will be deferred for three months (applies from 20 March 2020 to 30 June 2020).	UK-wide	All subpostmasters	<p>No action currently required from you.</p> <p>You will not need to make a VAT payment during this period.</p> <p>You will be given until the end of the 2020 to 2021 tax year to pay any liabilities that have accumulated during the deferral period.</p> <p>VAT refunds and reclaims will be paid by the government as normal.</p> <p>For further information or advice contact the NFSP on 01273 452324 (option 2).</p>
Deferral of Income Tax payments	Income Tax payments due in July 2020 under the Self-Assessment system will be deferred to January 2021.	UK-wide	All subpostmasters	<p>No action currently required from you.</p> <p>No penalties or interest for late payment will be charged in the deferral period.</p>
Time to Pay	Subpostmasters in financial distress can receive support with their tax affairs.
