

NFSP Forum Terms and Conditions

1. If you wish to use the forum you must register and become a forum member. As part of this you will be asked to accept the terms and in so doing you will be deemed to have consented to and be bound by the terms, the privacy policy and the forum rules. You must be a NFSP member before you can register. However, any use of the forum, of whatsoever nature constitutes your acceptance to the terms, the privacy policy and the forum rules which take effect the moment you first use the forum.
2. The NFSP reserves the right to change these terms, the privacy policy and the forum rules at any time by posting changes on the forum. It is your responsibility to refer to and comply with the most up to date version of the terms, the privacy policy and the forum rules on accessing the forum. Your continued use of the forum after changes are posted constitutes your acceptance to these terms, the privacy policy and the forum rules as amended.
3. The NFSP's proprietary rights, disclaimer of warranties, indemnities, limitations of liability and miscellaneous provisions shall survive any termination of your membership of the forum.
4. You agree and guarantee that any information you place upon the forum is original to you and does not infringe the copy right or any other rights of any other person.
5. The NFSP does not claim any rights of ownerships over the content you place upon the forum. You retain all ownership rights to the content you place upon the forum. However, you will allow the NFSP to use that content as set out in these terms.
6. By providing content you agree that the NFSP may use it, copy it and make any part of it available on the site, other internet sites or other communications mediums, or any other means of communication in any format.
7. You grant the NFSP a non exclusive world wide irrevocable licence to use, display, publish, transmit, copy, alter, store, sell and sublicense the content you place upon the forum for such purposes as the NFSP may require in its absolute discretion.
8. You agree to indemnify and keep indemnified the NFSP from and against all claims, damages, direct or indirect or consequential losses, expenses, costs and liabilities (including legal fees), judgments of whatsoever nature and howsoever arising from or related to your use and/or membership of the forum or arising from any breach or suspected breach of these terms, the forum rules or the privacy policy by you or anyone acting on your behalf in whatever capacity, or your violation of any law or the rights of any third party or in respect of any such violation as may occur by anyone authorised by you or acting on your behalf.
9. For the avoidance of doubt the privacy policy and the forum rules are part of these terms and conditions and are incorporated into these terms.
10. Without prejudice to the generality of clauses 5, 6 and 7 above, personal information you are asked to supply or that you supply voluntarily as part of registration or use of the forum will be used by the NFSP and its subcontractors, employees, agents and advisors to administer your membership or application for membership, to make decisions about whether the content you post to the forum should be accepted, rejected or used and NFSP may also at its sole discretion disclose this information to the Police, regulatory bodies, any relevant third party, or any legal advisors in connection with any alleged criminal offence or suspected breach of these terms by you or otherwise, where required by law.
11. Personal information you supply, together with the content you post to the forum and your application data will be seen by other users of the forum and you shall only provide information you are happy to be seen in this way.
12. By agreeing to these terms and using the forum you agree to any personal information held by the NFSP about you being used as set out above.
13. The NFSP assumes no responsibility or liability for use of the forum or any postings created by any of its users or members which do not necessarily and should not be taken as representing the views of the NFSP. The NFSP asks all users to use the forum in a

- way that complies with the terms of the forum rules and the privacy policy. However, you acknowledge that the users may post material that you consider to be offensive or objectionable. If you become aware of any misuse of the site you can alert the NFSP Moderator or contact the NFSP.
14. The NFSP reserves the right to modify, suspend, or discontinue the forum or any part of it at any time without notice or liability to you. The NFSP is entitled to suspend or terminate your membership of the forum or access to any part of the forum at any time if you are in breach of any of these terms or the forum rules and you agree that the NFSP shall have no liability to you in that event.
 15. You may terminate your membership of the forum at any time for any reason by notifying the NFSP accordingly. These terms remain in full force and effect, notwithstanding termination of your membership of the forum.
 16. The forum and the information posted to it in whatever form are provided "as is" and on "as available" basis without any representation, endorsement or warranty of any kind, including but not limited to implied warranties of satisfactory quality, fitness for particular purpose, non infringement, compatibility, security and accuracy. The NFSP will endeavour to use all reasonable care and effort to make the forum available to you at all times. However, you acknowledge that the forum is provided over the internet and so the quality and availability of the forum may be affected by factors outside the NFSP's reasonable control. NFSP is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, providers, computer equipment or software or failure of any e-mail or forum application on account of technical problems or congestion on the internet, traffic lines or at any website or any combination of these things or any other matter beyond the reasonable control of the NFSP. The NFSP makes no guarantees that the forum will be available for use or error free, or uninterrupted, or that defects on the forum will be corrected.
 17. The NFSP does not warrant the accuracy or completeness of any of the content of the forum or the reliability of any of the information displayed or posted to the forum. You acknowledge that your use of the forum or its content shall be at your sole risk. The decision to take part in the forum is entirely yours.
 18. The NFSP reserves the right at its sole discretion to edit, review or remove messages or delete registration of any one at will and without notice, who post messages that contravene the forum rules or in any other way act in a way in the sole opinion of the NFSP that is inconsistent with its forum rules or these terms, the privacy policy, or the NFSP's constitution or its intended use of the NFSP forum.
 19. The NFSP cannot accept any responsibility for any damage, loss, injury or disappointment suffered through use of its forum, or application to use its forum. In no event will the NFSP or any of its officers or trustees be liable for any damages whatsoever, or whether in contract, negligence or other action, including (but not limited to) damages for loss of use of forum, damage to equipment or other software, or loss of data or profits or for any other monetary loss or for any indirect or consequential damages, arising out of or in connection with the use (or inability to use) or the performance of the forum. In addition, in no event shall the NFSP, any of its officers or trustees be liable for any unauthorised use of the forum.
 20. Any copyright, trademarks or property rights in the forum (including the design arrangement and look and feel of the forum) and all materials, software or contents supplied as part of the forum other than the content you supply and your personal information, remains at all times the property of NFSP and protected by a copyright law.
 21. These terms, the forum rules and the privacy policy shall be governed by and construed in accordance with the rules of England. Any dispute arising from the use of the forum or the terms of the use of the forum will be decided only by the English Court.
 22. The forum is intended to be accessed only from the United Kingdom. The NFSP makes no representation that materials on the forum are appropriate or available for use at other locations and access to them from the territories where their contents are illegal is strictly prohibited. If you access the forum outside of the United Kingdom you are responsible for compliance with all local laws.

23. If any of the terms or parts thereof are held by any Court or competent authority to be unlawful, invalid or unenforceable, in whole or in part, this will not affect the validity of the remaining terms or parts thereof which will continue to be valid and enforceable to the fullest extent committed by the law.
24. The NFSP can transfer its rights and obligation under these terms to any company, firm or person, provided this does not effect your rights under the terms. You may not transfer or assign your rights or obligations under the terms to anyone else and your membership of the forum is personal to you.
